- I. Approval of Meeting Minutes – November 13, 2025  
Motion to approve minutes was put forth by Scott Sell and seconded by Steve Nickell. All in favor -- Minutes were approved by the committee.
- II. Academic Program(s):
  - Majors
    - Chaifetz School of Business (CSB) –New Major -- Business Administration, BS (CIM 834) with 15 concentrations – closing nine majors that will transition to concentrations. CSB explains the reason for this change is to ensure students complete 75% of major courses at SLU. Currently the residency rule requires 50% of major course work to be completed at SLU. Concentrations require 75% of course work to be completed at SLU. The major coursework residency policy for business would allow students to transfer 40 credits from another institution, which could articulate with all major required courses. Alternative option recommendations include: 1) a review of the curriculum; 2) faculty to review current transfer articulations; 3) allow a more open approach to the core courses that students can take which would also reduce the strain on CAS for some of the *required* core courses. Concerns: 1) Enrollment Management expressed concern as market analysis indicates decreased enrollment and visibility; 2) the academic catalog will have one-page for major vs individual pages for each major; 3) athletics prefer an individual major module; 4) the change moves the major to one assessment model

from many; 5) Sophia (student rep) reported that students feel a loss of identity and have concerns about employment opportunities. Students prefer the specificity in majors; 6) The CSB SGA Reps have asked Sophia to set up a meeting with Dean Nickerson and the VP of EM, Jean Marie Cox; 7) Fifteen concentrations in one major is overwhelming.

Tracy James' Comments: The reason that necessitates this change is the change in the transfer credit policy for undergraduate majors which has unwanted consequences. Because of the articulation language in the policy, students can graduate without upper-level course work at SLU. This is a structural problem.

The proposed change protects the integrity of these upper-level courses. Our benchmark institutions (Washington Univ., University of Michigan, University of North Carolina, Indiana University, UT-Austin, Georgia, Florida and Mizzou) offer a BSBA with concentrations. This structure should not affect market perception or enrollment. There is no correlation (cause & effect) from an enrollment perspective going back to Fall 2016 to suggest that the current enrollment numbers will decrease. Faculty overwhelmingly approved this change with only two dissenting.

Dr. Dorsey clarified some of the conversations above:

- The “transfer policy” does not articulate what transfers to SLU, faculty determine transfer course articulations.
- Undergraduate definitions and residency rules have not changed.
- EM provides official market analysis for new majors.
- The Core benefits our students in shaping our students in the formative development process.

The committee voted to table this proposed change until the January 2026 meeting where they will learn the outcome of the student meeting with the Dean and VP.
