Call to Order: Dr. Dorsey called the meeting to order at 9:00 am.

I. Approval of Meeting Minutes – October 2, 2025

- A motion to approve minutes was put forth by Sabrina Tyuse and second by Steve Nickell. All in attendance approved.

II. Academic Programs:

- Majors - None
- Minors
 - Cannabis Science and Operations (CIM 383) – Voluntary Closure. Closure is due to declining enrollment from Fall 2023, low graduation rates, and increased DFW rates. A teach-out plan is in place for students to complete by Summer 2026.
 - Italian Studies Minor (CIM 118) Voluntary Closure. No students or faculty in this minor. Teach-out plan is not necessary.
 - Russian Area Studies (CIM 157) – Voluntary Closure. One student is remaining in the program, and an individual completion plan has been designed for this student.
- Concentrations – none
- Micro-credentials
 - Spanish, Beginning (CIM 785) and Spanish, Advanced (CIM 786). The Intermediate Spanish micro-credential was approved in 2023. The program is proposing a Beginning and Advanced credential similar to French and German.
 - Geography and Environment (CIM 781) This micro-credential (9 credits) facilitates diverse perspectives by engaging students in the geographical,

- sociological, and anthropological study of the environment.
 - Mental Health and Society (CIM 782) This micro-credential (9 credits) is from the same department and has been developed to engage students in the sociological and anthropological study of mental health.
 - Social Research Methods (CIM 783) This micro-credential offers students the opportunity to develop/deepen their research skills in sociology and anthropology.
- Certificates
 - Cannabis Science and Operations (CIM 382) – Voluntary Closure. For the same reasons as the minor.
- ABM
 - Philosophy, BA to MA (CIM 758). The Registrar will work with CAS to update language in CIM around eligibility to be admitted.
 - Biomedical Engineering BS to Biomedical Engineering MS Accelerated Program (CIM 807). In year 4, students are required to do a capstone project at the 5000 level. External accreditation requires a capstone experience. The capstone will parallel to the project research thesis in year 5. The graduate class is acting as an undergraduate capstone; therefore, there needs to be a solution for meeting core requirements. Is it possible to offer the capstone with a bridge to the ABM? Scott will address these questions and be prepared to respond to the UAAC subcommittee committee November 13.
 - Spanish, BA to Spanish Education, MA (CIM 669). Voluntary closure due to low enrollment. Teach-out plans are in place.
 - Spanish, BA to MA (CIM 121). Voluntary closure due to low enrollment. One year teach-out plan is in place. Madrid will continue to offer this ABM. It is sunsetting only on the STL campus.

III. Old Business: Academic Program Proposal and Policy Approvals/Closures

- Biostatistics (CIM 463) – closure - approved by CADD and the Provost on 5-20-25. Will go to the BoT in December 2025.
- Meteorology, B.S. (CIM 541) – closure - approved by CADD and the Provost on 10-29-25. Will go to the BoT in December 2025.
- Meteorology, Minor (CIM 542) – closure - approved by CADD and the Provost on 10-29-25. No further approval is needed.
- Culinary Arts (CIM 722) – approved by CADD and the Provost on 10-29-25. No further approval is needed.
- Biostatistics, B.S. to Biostatistics and Health Analytics, M.S. - ABM - closure - approved by CADD and the Provost on 10-29-25. No further approval is needed.
- Biostatistics, B.S. to Biostatistics and Health Data Science, M.S. - ABM - closure - approved by CADD and the Provost on 10-29-25. No further approval is needed.

IV. Policy Review for AY 25-26: Dr. Dorsey

- Micro-credential – proposed revised language for section 4.0 Definitions for Academic Micro-credential:

We propose the following language – Remove: “All coursework must be completed after the creation of the micro-credential.” Replace – “no matter how long ago a current degree-seeking SLU student has taken the courses in the micro-credential even if they took the courses prior to the formation of the micro-credential they can get the credential as long as they declare it prior to graduation.” There will be no retroactive credentialing for students who have graduated. A motion to approve revisions was put forth by Sabrina Tyuse and seconded by Ellen Crowell. All members are in favor.

- Course extension policy - "I" Grade Policy. Suggested revisions:
 - Revisit one-year extension. Too many outstanding I's can set a student up for failure.
 - Limit the credits to 14.
 - Resolved "I" grade prior to the following Fall registration.
 - 90 days is enough time.
 - Faculty can ask for an extension (who do they appeal to).
 - Insert a caveat to address space and specific environmental facilities.

- Language Allowance for Testing Multilingual Learners. Optional Syllabus Statement. UAAD will review at November meeting.
- Policy on Class Recording – Dr. Lohe is looking for feedback by November 30th. Draft policy is posted on the UAAC drive.
