Graduate Assistant Office of Student Responsibility and Community Standards

General Description

Under the supervision of the Assistant Director, the Graduate Assistant (GA) assists in the overall operation of the Office of Student Responsibility and Community Standards, which includes investigating and adjudicating Community Standards cases (i.e. student code of conduct); interpreting and administering the Community Standards; creating and revising policies for the Community Standards; programming and facilitating restorative-based learning interventions for students, staff, and faculty on issues of alcohol and other drugs, policy compliance, hazing, and other topics associated with conduct and wellbeing.

Characteristic Job Tasks and Responsibilities

- Serve as a University hearing officer, upholding the University's Community Standards.
- Develop and facilitate educational sanctions for students.
- Advise peer education student group.
- Assist in maintaining up-to-date and accurate records and statistics related to disciplinary activity.
- Assist in the education of community standard board members, University hearing officers, Housing and Residence Life staff members, students, and parents.
- Update and maintain all training materials.
- Prepare correspondence to students, parents, and other University administrators.
- Undertake research projects related to student rights and responsibilities and trends in the field.
- Engage in research about prevention for alcohol use, drug use, hazing, and sexual misconduct.
- Perform benchmarking research.
- Develop and administer educational assessments.
- Maintain AlcoholEdu for Sanctions module, including sanction follow-up.
- Oversee the administration of the Office's education program: The Billikens ACT Workshop.
- Serves as a facilitator for BASICS (Brief Alcohol Screening In College Students).
- Other duties as assigned.

Requirements

The GA requirements include enrollment in a graduate program at Saint Louis University, a bachelor's degree, and a significant record of leadership and excellent communication skills. In addition, they must have a desire to work within a progressive and challenging Jesuit education environment. Preference will be given to candidates studying Student Affairs and Higher Education Administration.

Expectations and Remuneration

\$2000 stipend/month, University graduate student health insurance (student only, if needed), and academic tuition up to \$9750 for the term of appointment.
